## General Law Cities Type A, B, or C?










#### **Borrowing Provision**

 Type B cities have the same authority, duties, and privileges as a Type A city, unless there is a conflicting state provision regarding only Type B cities.

 Type C cities have the same powers as a Type B or Type A city, unless the law specifically provides otherwise



#### Home Rule Cities







#### Home Rule Authority

A home rule city may do anything authorized by its charter that is not specifically prohibited or preempted by the Texas Constitution or state or federal law; A general law city has no charter and may *only* exercise those powers that are specifically granted or implied by statute.




# What are some differences in general law and home rule cities?





#### Annexation



Home Rule: unilateral annexation with state rules

**General Law:** mostly requested annexations with rules



#### **Property Taxes**

- Home Rule: \$2.50 per \$100 valuation
- Type A: \$1.50 per \$100 valuation
- Type B: .25 per \$100 valuation
- Type C: Same as Type A if 501-4,999 population or Same as B if 201-500 population





### Initiative, Referendum, and Recall

- Only home rule cities possess these powers
- Home Rule Charter gives authority
- Initiative: Citizens want an ordinance
- Referendum: Citizens want to repeal on ordinance
- Recall: Citizens want to remove one or more members of governing body



## **Changing City Type**

#### Changing to a Type A City

- 1. Affirmative vote of 2/3 of city council;
- 2. Record taken and signed by mayor; and
- 3. Record filed and recorded in county clerk's office.

#### **Changing to Home Rule**

- 1. City council may order an election to create a charter commission, with 2/3 vote of council; or
- Council must order an election if presented with a petition signed by at least 10 percent of the qualified voters



#### State Preemption of Local Authority



Transportation Code Sec. 545.425 State-level misdemeanor to drive in a school zone while talking on a cell phone




#### **Dangerous Dogs**

- Sec. 822.047. LOCAL REGULATION OF DANGEROUS DOGS. A county or municipality may place additional requirements or restrictions on dangerous dogs if the requirements or restrictions:
- (1) are not specific to one breed or several breeds of dogs; and
- (2) are more stringent than restrictions provided by this subchapter.





#### **Fire Sprinklers**







### Oil & Gas Regulations

- HB 40 (2015): oil and gas operation subject to the exclusive jurisdiction of the state
- Cities may not enact or enforce ordinance that ban, limit, or otherwise regulate oil and gas operation
- Cities can regulate aboveground activity if it is "commercially reasonable"
