# State Preemption: State Interference Preemption:

Allows a higher level of government to limit or eliminate the power of a lower level of government

Used to ensure state and local regulations conform, create uniform minimum standards to advance wellbeing and equity

Misused to stop local laws that promote equity, health, and civic participation; used to limit the voice and power of people of color and women



## Past and New Preemption Laws Limit Local Efforts to Protect Public Health

- The pandemic has laid bare the high cost of a decade of state preemption designed to undermine local authority and independence. Preemption has hampered local response; made it harder to protect lives and livelihoods.
- Policies preempted before the pandemic, including paid sick days, equitable housing, minimum wage, and broadband forced cities to start from behind.
- Same people who would have benefited most from these preempted polices People of Color, women, workers in low wage jobs – are the people suffering the most from the pandemic.



## Past and New Preemption Laws Limit Local Efforts to Protect Public Health

- Express preemption included in Executive Orders hobbled local efforts to vulnerable communities Georgia, Texas, South Carolina, Mississippi
- States are threatening to punish cities by withholding state (FL) or federal funds (NE), taking or threatening legal action (GA, TX)
- The recovery will also be hamstring by preemption fiscal authorities, housing vaccines, voting, worker safety, corporate immunity, emergency managers
