



CITIZEN JOURNALISTS & FREEDOM AUDITORS



Treat them exactly the way you would any journalist.



REPORTERS 3 Types

National | Visiting
State | Visiting or Invested
Local | Always invested

Each has a different reaction to no comment



REPORTERS

- They want to get through the day
- They need to get their work done
- They really do want to get it right
- They need to present a "hook" in their story
- They need to make sure everyone who needs to be interviewed gets interviewed

They don't think they are "creating a narrative."

MORE WORK





Reporters expect legal to be more sophisticated than other city departments

WHATNOTTO DO DON'T ARGUE

Or slam the door
Or hang up the phone
Or stick your tongue out

Reporters can call anyone. They chose to call you.

Banish"No Comment"

PROCESS

Everything legal does has a process. Talk about that.



Banish "No Comment"

THE TIMELINE

Different from the process

Discuss how the event/lawsuit unfolded



Banish"No Comment"

YOUR ROLE

Discuss how you will perform your job



Banish "No Comment"

THE COUNCIL

Discuss how this event or legal process will make it to the agenda
Discuss why the council makes the decision.



Reporters know less about how government works than you think.

Banish No Comment

WHY YOU HAVE NO COMMENT

You absolutely can discuss privacy, legal positions and other reasons you are not trying the matter in the press.



TIP: If you use this, tell them you give them they will be the FIRST to receive the information



PREPYOURSELF The Diamond Method OPENING STATEMENT

Reframe the question posed as a statement

Comment on what you think of the question (It's always a good one.)



PREP YOURSELF The Diamond Method

CENTER STATEMENT

3 parts

Start with a medium sized point | refer to past developments or what has been reported already

Make the **big point** | the new information or development you want to make sure the public knows

Finish with **final point** | a "tease" or something the public or media might want to look for

PREPYOURSELF The Diamond Method

RAP UP

What you can do next
Where they can go for more information
Ask if you spoke plainly enough
Tell them you are happy to answer any other questions

OPEMING

RAP UP
