

#### Code Drafting Principles

City Code Provision is a Law

Are there existing laws on the topic?

What exactly is your client wanting to do with the law?

#### Code Drafting Principles

What exactly does your client want to make people do or stop doing?

Write the code with law enforcement/inspector in mind

Include findings necessary for potential court challenges

#### Drafting Tips

**Definitions** 

Write in Active Voice

Try not to "shall" the City

#### **Drafting Tips**

Creating an offense? Use affirmative defenses, not exceptions

Consider the prosecutor's complaint drafting needs

New law/program? Consider a public education period



- **3-2-61:** Killing Birds
- 3-2-1: Animals at Large
- Texas Health and Safety Code: Definition of Dangerous Animals
- 3-5: Prohibits Wild Animals in the City

10-21: At-Large— Animals Generally

- 10-16: Hogs and Pigs Prohibited
- 10-18: Harboring Wild Animals

Answer: Mexican Free-Tailed Bat

What is the official Texas State Reptile?

Answer: Texas Horned Lizard



#### LIVESTOCK

#### **Enclosure:**

• 3-2-14: 100 feet from adjoining property

• 10-19: Livestock Enclosures

#### Grazing:

■ 3-2-41: No staking livestock



#### FERAL HOGS

#### Feral Hogs:

- Resolution 20121213-003:Killing on city-owned preserve lands
- 102-22: Disposal and Collection of Dead Animals



#### ANIMALS AT THE AIRPORT

#### No Dogs at the Airport EXCEPT:

• 13-1-33: law enforcement K9; guide dogs; dogs in transport



What is the official Texas State Insect?

Answer: Monarch Butterfly



What is the official Texas State Horse?

Answer: American Quarter Horse





#### Bees:

- 3-6-2: No Threatening Colonies
- 3-6-5: Aggressive Colonies
- 3-6-6: Colony Density



#### **URBAN FARMS**

#### **Chickens:**

**3-2-16: Coops** 

• 3-2-25: At Large

• 3-2-61: Killing

 10-20 – proximity of poultry enclosures to dwellings



#### **URBAN FARMS**

#### Goats:

• See enclosure laws

Hogs, Pigs, or Swine:

■ 3-2-42: No more than 2





What is the official Texas State Pollinator?

Answer: Western Honey Bee



#### FEEDING/SHOOTING DEER

#### Feeding:

• 10-8-3 and 10-8-6: Don't do it

#### Shooting

• 3-2-4: Don't do it



## LAND USE DEFINITIONS APPLICABLE TO ANIMALS

#### **Examples:**

• 25-2-4(15): Carriage Stable

■ 25-2-4(39): Kennels

■ 25-2-4(52): Pet Services

■ 25-2-4(68): Stable

#### Recent Changes in the Law

#### Dangerous Dogs –

- Tex. H&S § 822.0424 appeal to county court
- But see dog that causes death or serious bodily injury
- Cruelty
  - SB 1232 2017 Leg. if convicted of new Penal Code section for "Bestiality" all animals may be seized
  - Chase v. State, 448 S.W.3d 6 affirmative defense

Lira v. Greater Houston German Shepherd Dog Rescue 488
 S.W.3d 300
