
Meet Dewy Suem

- Sometimes uses prosthetic/sometimes wheelchair
- Doesn't like the City

- Cannot access sidewalks in front of City's shooting range
- Mayor Mitey = avid shooter
- Dewy = does not like guns






Several Laws – All (practically) Mean the Same Thing

DOT Role


- Obtain Compliance
- Seek Enforcement
- Mechanism for Complaints

What NOT to do

- Tell Feds to Go Away
- Tell Feds Dewy Doesn't Shoot
- Tell Feds the City Cannot Afford to Fix the Area. (qualified)



Practically What to Do

- Evaluate the Area
- Pull the Transition Plan
- Review for Inaccessibility
- Determine Requirements for Correction
- If possible, make correction now

Files Multiple Complaints (on behalf of brother)

- •132 intersections
- 6 facilities
- No ramps within shooting club

Check the Regs

- •28 C.F.R. § 35.149, .150, & .151.
- •What's Required
- •What's the Fix





City Did Not Adopt Transition Plan

- §35.150(d) dealing with existing facilities
- City was required to adopt a transition plan within six months of the January 26, 1999
- Transition existing facilities to compliant standards

No Plan – Now What!

- Five Rules to Help City Attorney Response
- Doesn't matter why no plan
- •TxDOT compiling City list

1. Don't Panic



2. Determine Current Policy for New Facilities

- Yes NEW facilities
- Cycle out mentality
- Determine if current policy has been followed

3. Determine Logistics of Creating Plan

- Inventory Big Cost
- Repair Schedule Planned Cost
- Schedule for Inventory and Transition Plan

4. Out-of-Box Thinking

- On Temporary Basis increase accessibility where possible
 - Alternative routes
 - Shuttling from compliant location
